

SPONSORSHIP AGREEMENT



Between the undersigned:

Between, on the one hand, the non-profit association Cluster for Logistics Luxembourg a.s.b.l. located at 7 rue Alcide de Gasperi, L-2981 Luxembourg, hereafter referred to as "The Association".

1. Purpose of the Convention
